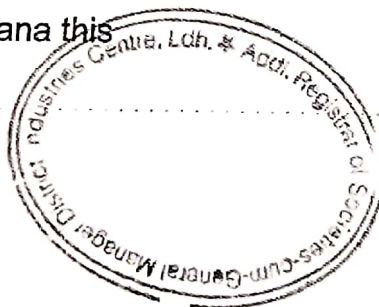



3. Area of Operation : District of Ludhiana.
4. AIMS AND OBJECTS:-
- The Society is established to manage the run the institute SHRI GURU HARGOBIND SAHIB PUBLIC SENIOR SECONDARY SCHOOL on modern and scientific lines and to work for the all-round development of institution.
 - To start educational institutions at different places of Ludhiana right Nursery to Secondary Standard.
 - To spread propagate and enforce the study of truth, non-violence and love.
 - To voluntary help will impart of education to the children who are unable to attend regular schools due to poverty. The society will provide uniforms, books, stationery to the poor children free of cost.

 - To organize seminars, Educational workshops for creating educational awareness among the general masses.

 - n) To give sports facilities to students for the development of mental, physical or moral uplift of students so as to make them good citizens.
 - o) To recruit highly qualified teachers/professors in various subjects who are alive to social need of the children.
 - p) To strive for and obtain official registration, affiliation of the institutions set up and run by the society.
 - q) To accept donation, grants, presents, gifts and other offerings in the shape of moveable and/or immovable properties from the general public and Govt. Authorities and to utilize the same for attainments of the Aims and objects of the society.
 - r) To purchase/ acquire the land and/or the building in the name of society through purchase, lease/will or legacies from the public/Govt. authorities for the uplift or fulfillment of the Aims and objects of the society.
 - s) To encourage the children about cleanliness and good hygienic conditions.
 - t) To Vehemently oppose and breach against the drinking, casticism, dowry, orthodoxy and other evils prevailing in the society so that the women folks may achieve their proper place in society.
 - u) To ensure to avoid the antomiciation and harmful elements which are against the principles of the society.
 - v) To celebrate and arrange religious functions pertaining to all sections of the society.
 - w) To struggle for the development of the Area.
 - x) To arrange sampling plantation to improve environment conditions and to provide the same to the interested persons.
 - y) To publish books and maintain library for the moral, cultural and academic welfare of the children and the society.
 - z) To do all other lawful acts, deeds or things which are necessary conductive and incidental for the attainment of any of the objects stated above.
